

#### **Recommended Cargo Size Reference**



The recommended package size is within  $60 \times 60 \times 50$  cm, and the recommended chargeable weight is within 30 kg. If the shipment exceeds 110 cm in any dimension or has a chargeable weight over 30 kg, additional fees will apply. Please refer to the Additional Charges Information Page for details.

#### The international formula for calculating volumetric weight is as follows



\* Volumetric weight = Length × Height × Width ÷ 6000 | \* Volumetric Weight Ratio: 1:167 | \* Actual Weight Ratio: 1:360 This formula is used to calculate the volumetric weight of goods, especially for items that are lightweight but bulky. It is commonly used in shipping service calculations to determine the chargeable weight. For example, if you need to transport 1kg of cotton products that occupy 200 CBM of transport space, charging based on the actual weight of 1kg would not be reasonable. Therefore, the volumetric weight of the goods needs to be calculated for proper billing.

For Example: Chargeable Weight = 25kg



Personal Items Shipment	Can I mail personal items to Australia?  Yes, but personal items are still subject to customs inspection. Certain items, even for personal use, require an import permit.

You can check whether your goods have arrived at the warehouse by visiting our website. This includes details such as arrival time, number of boxes, and the Chinese logistics tracking number.
